Reminder: Correction Request Workflow

The DMC has retired the Eligibility Correction Request and the Screening Correction Request programs from the Frontier Science Portal for the ACTG and IMPAACT projects.

To initiate a correction to the Eligibility Checklist or Screening Checklist, site users must open DM from Site queries on the appropriate question(s) (i.e. log line(s)) on the Eligibility Checklist Log or Screening Answers Log eCRF in Rave. This applies to corrections requests for both ACTG and IMPAACT studies. The relevant training materials available on the Frontier Science Portal have been updated. The program links remain on the Frontier Science Portal to remind site staff to use the new workflow, but they do not provide access to the retired checklist correction request programs.

Creating a DM from Site Query

1. Navigate to a Study > Site > Subject > Form.
2. Click the icon to the right of the field for which you want to add a DM from Site query.
3. Select Open Query from the dropdown of marking types.
4. Select DM from Site from the dropdown of marking groups.
5. Enter the query text (up to 1000 characters) in the text box. The new response/value must be indicated within the text of the query, along with the reason for the correction. If a question needs to be removed as a result of a skip logic change, or calculation questions are affected by the original data correction, a DM from Site query must be opened on each question that needs to be updated. If a question needs to be added as a result of a skip logic change, the new question number and response must be included within the query text on the original question.
6. Require Response is selected by default. This must remain checked in order to track the PDM's response.

4. What was the date the medical history condition/event started?

7. Click **Save**. The saved query will have a pink background.
